Negotiated charges must be included on the dealer’s quote and on state’s UGU purchase order. Authorized dealer/reseller shall be responsible for removal and disposal of packing materials and other debris.

**HPFi ORDER ENTRY:** HPFi shall not enter any order before receiving a copy of the dealer’s quote and/or Using Government Units purchase order showing state agency’s net cost per unit and any installation and delivery charges. Dealer will be invoiced for 1% of any delivery or installation charges. HPFi will pay South Carolina State Purchasing the 1% administration fee against the total cost the state pays for Furniture including Installation and Delivery charges.
